1. *Badimalika Municipality Office of the Municipal Executive, Martadi, Bajura* invites electronic bids from eligible bidders for the construction of **CONSTRUCTION OF JADANGA KORDHA ROAD AT BADIMALIKA MUNICIPALITY WARD NO 6, BAJURA** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 3,47,00,000.00** And Bidding Capacity **NRs 2,28,75,000.00**
 - Minimum Work experience of similar size and nature: **One contract of road works with value at least NRs. 91,50,000.00**
 - Construction Experience in Key Activities
P.C.C M15= CUM PER YEAR
P.C.C. M20=394 CUM PER YEAR
TMT OR TOR REINFORCEMENT = 14.04 TON PER YEAR
EARTH WORK = 15,480 CUM PER YEAR
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
