## Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges





1. The Government of Nepal (GoN) has allocated TB-SWAp funds to Badimalika Municipality for Trail Bridge Program and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Badimalika Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Badimalika Municipality or [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp)
5. Bidding documents may be purchased from the office of Badimalika Municipality, Bajura or [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the **16 Dec 2019. (30 days** from the first date of publication of this notice).
6. For Purchase Bids, bidder has to deposit in Rastya Banijya Bank, Bajura Branch Nrs 3000.00 cash in Deposit at the name of Badimalika Municipality Sanchit Account No 4070304024202 and submit bank deposit voucher along with the bid.
7. Bids must be submitted to the office of Badimalika Municipality, Bajura or through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp), on or before **12:00 noon on 17 Dec 2019 (01 Paush 2076)**. Documents received after this deadline shall not be accepted.
8. Bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 17 Dec 2019 (01 Paush 2076)** at the office of Badimalika Municipality, Bajura. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 80,000 (Eighty Thousand only)**, which shall be **valid for 30 days** beyond the bid validity period.
9. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Rastya Banijya Bank, Bajura Branch at the name of Badimalika Municipality, Bajura Dharuti Account No 4070303003004 and submit bank deposit voucher along with the bid.
10. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
