The Government of Nepal [GoN] has allocated funds towards the cost of **Construction of Kalajagra Tourism Park and Foot Trail To Kalajagra at Badimalika Municipality 7, Bajura** and intends to apply part of the funds to cover eligible payments under the Contract **ID:- BMO/WORK/BAJURA/NCB/16/077-078**. Bidding is open to all eligible as per Section V of bidding document.
2. Badimalika Municipality Office invites sealed bids or electronic bids from eligible bidders for the construction of Project mentioned in table below under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:



3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Badimalika Municipality, Martadi, Bajura** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document of NRs 5,000.00 (Five Thousand Rupees only) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Pre-bid meeting shall be held at **Badimalika Municipality, Martadi, Bajura** at 13 hrs on 3rd Jestha 2078.
7. Electronic bids (one Technical Bid and another Price Bid) must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hrs. on 13th Jestha 2078**. Bids received after this deadline will be rejected.
8. The Technical bids will be opened electronically in the presence of Bidders' representatives who choose to attend at **13 Hrs on 13th Jestha 2078** at the office of **Badimalika Municipality Martadi, Bajura**. Bids must be valid for a period of **120 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1600000** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. If Bidder wish to Submit the bid security in the form of cash bidder has to deposit cash in dharauti Account no 4070100303000002 of Badimalika Municipality Office Bajura at **Rastriya Banijya Bank Martadi Branch, Bajura** and Submit Bank Deposit Voucher along with a Bid.
11. **Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.**
12. Badimalika Municipality Office Martadi, Bajura Reserves Right to accept or Reject any or all bids, The bidding process and reject all Bids without Assigning any Reason or whatsoever.
13. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
